Judicial Review

We are going to court for Lucy again. Her enclosure and conditions are in clear violation of the Alberta Zoo Regulations. Although costly, we see this as the only route to pressure the Government of Alberta to enforce the law.



Rescue

This five-month-old feral kitty lives with a small colony in a storage yard. Here he is in a humane trap on his way to the vet for a neuter, shots and a check-up. To stop the cycle of breeding, we will work to neuter/spay every one. We have set up shelters and will continue to feed the colony.

Are you angry at the exploitation of animals and outraged at the many injustices done to them? These are feelings many people share when they see a lonely, sad-looking elephant in a zoo, a rodeo animal trembling with fear, the agony of a pig immobilized in a tiny stall on a factory farm and so many other suffering and abused animals. The only way you and I can make a difference for these animals is to say: I won't turn away.

For almost 20 years, Voice for Animals has stepped in when we heard of an animal in distress or needing an advocate. With your help we can continue building on these accomplishments and victories:

Guzoo's doors are closed. This infamous zoo has been shut down for good. The provincial government decided not to go to court to fight a judicial review launched by V4A and, instead, denied the operating permit to this filthy, substandard roadside zoo.

- Voice for Animals mounted a great turn-out to protest the Canadian Finals Rodeo and helped to expose the death of a calf in the calf roping event.
- Voice for Animals is putting a major effort into getting Lucy sent to a sanctuary. Once again, we are going through the courts with a judicial review.
 This is an attempt to force the Government of Alberta to take action for Lucy.
- Voice for Animals took part in A Taste of Edmonton to promote a plant based diet. We also did numerous informational displays, hosted speakers and handed out leaflets at events to educate the public about the inhumanity of factory farms.

On behalf of the animals we work to protect and all of us at Voice for Animals, we wish you a Merry Christmas and a happy holiday season.
